## The Opportunity

The Sea to Sky Division of Family Practice seeks a Data Analyst to assist with the Assessment and Planning Phase of the Division's "A GP for Me" project.

Reporting to the Project Manager and working in close consultation with the Division Coordinator and key stakeholders, the Data Analyst will be accountable for providing extensive data collection and analysis in support of the goals of A GP for Me, resulting in a collated report that will be utilized for planning purposes.

## Responsibilities

The Data Analyst will:

- Work collaboratively with A GP for Me Physician Project Leads, a Division Coordinator, and a contracted Project Manager
- Engage Patients, Physicians, Specialists, Health Authority partners, Allied Healthcare Professionals and various community partners to identify and source data relevant to the project.
- Identify, assemble, analyze and synthesize a variety of data related to local population(s) and public health resources
- Ensure that data is collected in a manner that meets standard health data collection standards and which lends itself to validation.
- Ensure that the security and confidentiality of all data is maintained
- Generate report, collating all available data and survey findings.
